Arkansas Code Title 14, Chapter 54, Subchapter 14, is 23 amended to add an additional section to read as follows: 24 14-54-1412. Local option for open possession of handgun in public. 25 (a) The governing body of a municipality may pose to all qualified 26 electors residing within its limits the question of whether to specifically 27 prohibit the open possession of a handgun in public. 28 (b) The question under subsection (a) of this section shall be 29 presented to the electorate of the municipality at an election held only on a 30 regular biennial November general election day. (c)(1) After a vote in the affirmative to specifically prohibit the 31 32 open possession of a handgun in public, the governing body of the 33 municipality may pass an ordinance that states that a person shall not openly 34 possess a handgun in public within the limits of the municipality. 35 (2)(A) An ordinance passed under this subsection may create a 36 violation and penalty for the violation of open possession of a handgun that
