## AN ACT REQUIRING ANNUAL REPORTS ON USE OF FORCE BY STATE AND MUNICIPAL POLICE OFFICERS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Section 7-282e of the general statutes is repealed and the
following is substituted in lieu thereof (*Effective from passage*):

3 (a) Each law enforcement unit, as defined in section 7-294a, shall 4 create and maintain a record detailing any incident during which a 5 police officer, as defined in section 7-294a, (1) uses physical force that is likely to cause serious physical injury, as defined in section 53a-3, to 6 7 another person or the death of another person, including, but not 8 limited to, striking another person with an open or closed hand, club 9 or baton, kicking another person or using pepper spray or an 10 electroshock weapon on another person, or (2) discharges a firearm, 11 except during a training exercise or in the course of dispatching an 12 animal. Such record shall include, but not be limited to: The name of 13 the police officer, the time and place of the incident, a description of 14 what occurred during the incident and, to the extent known, the names 15 of the victims and witnesses present at such incident.

16	(b) Not later than October 1, 2019, the Police Officer Standards and
17	Training Council, established pursuant to section 7-294b, shall develop
18	and promulgate a standardized form for an annual report that
19	compiles the contents of records a law enforcement unit maintains
20	pursuant to subsection (a) of this section. The form shall require
21	statistics on each incident that is the subject of the record, including,
22	but not limited to, (1) the race and gender of each person on whom
23	force was used, provided the identification of such characteristics shall
24	be based on the observation and perception of the police officer
25	involved in the incident, (2) the location of each incident, the type of
26	force used and the activities that led to the use of force, and (3) any
27	injury suffered by a person against whom force was used.
28	<u>(c) Not later than January 15, 2020, and annually thereafter, the</u>
29	Division of State Police within the Department of Emergency Services
30	and Public Protection and each municipal police department shall
31	submit an annual use of force report using the form developed and
32	promulgated pursuant to subsection (b) of this section to the Criminal
33	Justice Policy and Planning Division within the Office of Policy and
34	Management.
35	(d) The Office of Policy and Management shall post the annual
36	reports submitted pursuant to subsection (c) of this section on its
37	Internet web site.

This act shall take effect as follows and shall amend the following sections:
