## AS PASSED SENATE

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 2 of Chapter 1 of Title 37 of the Official Code of Georgia Annotated,
- 2 relating to powers and duties of the Department of Behavioral Health and Developmental
- 3 Disabilities, so as to provide for the certification, rather than licensing, of crisis stabilization
- 4 units; to provide for policies and procedures; to remove certain provisions relating to the
- 5 promulgation of rules and regulations; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 Article 2 of Chapter 1 of Title 37 of the Official Code of Georgia Annotated, relating to
- 9 powers and duties of the Department of Behavioral Health and Developmental Disabilities,
- 10 is amended by revising Code Section 37-1-29, relating to crisis stabilization unit defined,
- 11 licensure of units, minimum standards and requirements, designation as an emergency
- 12 receiving facility, legislative intent, and rules and regulations as follows:
- 13 "37-1-29.

- 14 (a) As used in this Code section, the term 'crisis stabilization unit' means a short-term
- residential program operated for the purpose of providing psychiatric stabilization and
- detoxification services that complies with applicable department standards and that
- 17 provides brief, intensive crisis services 24 hours a day, seven days a week.
- 18 (b) The department shall be authorized to <del>license</del> <u>certify</u> crisis stabilization units pursuant
- 19 to this Code section for the purpose of providing psychiatric stabilization and detoxification
- services in a community based setting rather than inpatient hospitalization and other higher
- 21 levels of care.
- 22 (c) The department shall establish minimum standards and requirements for the <del>licensure</del>
- 23 <u>certification</u> of crisis stabilization units <u>in its policies and procedures</u>. Such <del>standards and</del>
- 24 requirements policies and procedures shall include, but not be limited to, the following:
- 25 (1) The capacity to carry out emergency receiving and evaluating functions;
- 26 (2) Voluntary and involuntary admission criteria;

27 (3) The prohibition to hold itself out as a hospital or bill for hospital or inpatient services;

- 28 (4) The unit is operated by an accredited and licensed, if applicable, health care
- authority;
- 30 (5) The unit has operating agreements with private and public inpatient hospitals and
- 31 treatment facilities;
- 32 (6) The unit operates within the guidelines of the federal Emergency Medical Treatment
- and Active Labor Act with respect to stabilization and transfer of clients;
- 34 (7) Length of stay;
- 35 (8) Designation of transitional beds;
- 36 (9) Billing;
- 37 (10) Physician and registered professional nurse oversight;
- 38 (11) Staff to client ratios;
- 39 (12) Patient restraint or seclusion;
- 40 (13) Safety and emergency protocols;
- 41 (14) Pharmacy services;
- 42 (15) Medication administration; and
- 43 (16) Reporting requirements.
- 44 (d) A crisis stabilization unit shall be designated as an emergency receiving facility under
- Code Sections 37-3-40 and 37-7-40 and an evaluation facility under Code Sections 37-3-60
- and 37-7-60, but shall not be designated as a treatment facility under Code Section 37-3-80
- 47 or 37-7-80. Crisis stabilization units may admit individuals on a voluntary basis.
- Individuals may be provided 24 hour observation, detoxification and stabilization services,
- 49 medication prescribed by a physician, and other appropriate treatment or services.
- 50 (e) No entity shall operate as a crisis stabilization unit without having a valid <del>license</del>
- 51 <u>certificate</u> issued pursuant to this Code section.
- 52 (f) Application for a license certificate to operate a crisis stabilization unit shall be
- submitted to the department in the manner prescribed by the department's rules and
- 54 regulations policies and procedures.
- 55 (g) The department shall issue a license certificate to an applicant who meets all the rules
- and regulations standards and requirements as set forth in the department's policies and
- 57 <u>procedures</u> for the <u>licensure</u> <u>certification</u> of crisis stabilization units. The <u>license</u> <u>certificate</u>
- shall be nontransferable for a change of location or governing body.
- 59 (h) Each licensee certified crisis stabilization unit shall permit authorized department
- 60 representatives to enter upon and inspect any and all premises for which a license
- 61 <u>certificate</u> has been granted or applied for so that verification of compliance with all
- 62 relevant laws or regulations can be made.

(i) The department may deny any license application for certification which does not meet all the rules and regulations standards and requirements set forth in the department's policies and procedures for the licensure certification of crisis stabilization units and may suspend or revoke a license certification which has been issued if an applicant or a licensee certified crisis stabilization unit violates any such rules and regulations policies and procedures; provided, however, that before any order is entered denying a license certification application or suspending or revoking a license certification previously granted, the applicant or license certificate holder, as the case may be, shall be afforded an opportunity for a hearing as provided for in Chapter 13 of Title 50, the 'Georgia Administrative Procedure Act.'

- 73 (j) Any program licensed certified as a crisis stabilization unit pursuant to this Code section shall be exempt from the requirements to obtain a certificate of need pursuant to
- 75 Article 3 of Chapter 6 of Title 31.

- 76 (k) It is the intent of the General Assembly that this Code section provide a public benefit
- and comply with all safety net obligations in this title and that patients without private
- health care coverage receive priority consideration for crisis stabilization unit placement.
- 79 (l) The department shall promulgate rules and regulations in accordance with the General
  80 Assembly's intent as set out in subsection (k) of this Code section to implement the
- 81 provisions of this Code section."

82 SECTION 2.

83 All laws and parts of laws in conflict with this Act are repealed.
