A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 3 of Article 4 of Chapter 11 of Title 16 of the Official Code of Georgia
- 2 Annotated, relating to carrying and possession of firearms, so as to require the reporting of
- 3 weapons carry license and renewal license information to the Georgia Crime Information
- 4 Center for affiliation with certain records such that, for the safety of officers and citizens, law
- 5 enforcement officers may have foreknowledge of the possible presence of a firearm when
- 6 effecting a traffic stop or other investigative encounter; to provide for an exception; to amend
- 7 Article 2 of Chapter 3 of Title 35 of the Official Code of Georgia Annotated, relating to
- 8 Georgia Crime Information Center, to provide for restricted access to information; to provide
- 9 for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

11 SECTION 1.

- 12 Part 3 of Article 4 of Chapter 11 of Title 16 of the Official Code of Georgia Annotated,
- 13 relating to carrying and possession of firearms, is amended by revising subsection (k) and
- 14 adding a new subsection to Code Section 16-11-129, relating to weapons carry license,
- 15 temporary renewal permit, mandamus, and verification of license, as follows:
- 16 "(k) **Data base prohibition.** Except as provided for under subsection (k.1) of this Code
- 17 <u>section, a A person or entity shall not create or maintain a multijurisdictional data base of</u>
- information regarding persons issued weapons carry licenses.
- 19 (k.1) Providing weapons carry license information to the Georgia Crime Information
- 20 <u>Center.</u> The judge of the probate court, upon issuance of a weapons carry license or a
- 21 <u>renewal license, shall provide the Georgia Crime Information Center with the application</u>
- 22 <u>information of the issued weapons carry license or renewal license.</u> The Georgia Crime
- 23 <u>Information Center shall affiliate such information with matching records of persons within</u>
- 24 motor vehicle and driver's license data bases maintained by the center such that such
- 25 persons are designated as weapons carry license holders in such data bases."

27 Article 2 of Chapter 3 of Title 35 of the Official Code of Georgia Annotated, relating to

- 28 Georgia Crime Information Center, is amended by adding a new Code section to read as
- 29 follows:
- 30 "35-3-37.1.
- 31 <u>Information provided to the center pursuant to subsection (k.1) of Code Section 16-11-129</u>
- 32 <u>shall be available only to criminal justice agencies for law enforcement or criminal</u>
- 33 <u>investigative purposes."</u>

34 SECTION 3.

35 All laws and parts of laws in conflict with this Act are repealed.
