A BILL TO BE ENTITLED AN ACT

- 1 To amend Title 16 of the Official Code of Georgia Annotated, relating to crimes and
- 2 offenses, so as to designate the existing crime of highjacking a motor vehicle as being in the
- 3 first degree and create a new crime of highjacking a motor vehicle in the second degree; to
- 4 provide for penalties; to change provisions relating to burglary in the second degree
- 5 involving a vehicle; to amend the Official Code of Georgia Annotated to provide for
- 6 conforming cross-references; to provide for related matters; to repeal conflicting laws; and
- 7 for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 PART I
 10 SECTION 1-1.

- 11 Title 16 of the Official Code of Georgia Annotated, relating to crimes and offenses, is
- amended by revising subsections (b) through (d) of Code Section 16-5-44.1, relating to
- 13 highjacking a motor vehicle, as follows:
- 14 "(b)(1) A person commits the offense of hijacking a motor vehicle in the first degree
- when such person while in possession of a firearm or weapon obtains a motor vehicle
- from the person an individual or the presence of another individual by force and violence
- or intimidation or attempts or conspires to do so.
- 18 (2) A person commits the offense of hijacking a motor vehicle in the second degree when
- 19 <u>such person obtains a motor vehicle from an individual without his or her consent or from</u>
- 20 <u>the presence of another individual without his or her consent or attempts or conspires to</u>
- 21 <u>do so.</u>
- 22 (c)(1) A person convicted of the offense of hijacking a motor vehicle in the first degree
- shall be punished by imprisonment for not less than ten nor more than 20 years and a fine
- of not less than \$10,000.00 nor more than \$100,000.00, provided that any person who has
- previously committed an offense under the laws of the United States or of Georgia or of

any of the several states or of any foreign nation recognized by the United States which 26 27 if committed in Georgia would have constituted the offense of hijacking a motor vehicle 28 shall be punished by imprisonment for life and a fine of not less than \$100,000.00 nor 29 more than \$500,000.00. The punishment imposed pursuant to this paragraph shall not be <u>deferred</u>, <u>suspended</u>, <u>or probated</u>. For purposes of this subsection <u>paragraph</u>, <u>the term</u> 30 31 'state' shall include the District of Columbia and any territory, possession, or dominion 32 of the United States. (2) A person convicted of the offense of hijacking a motor vehicle in the second degree 33 34 shall be punished upon a first conviction by imprisonment for not less than one nor more 35 than 20 years and a fine of not more than \$5,000.00. Upon a second conviction for hijacking a motor vehicle in the second degree, a person shall be punished by 36 37 imprisonment for not less than three nor more than 20 years and a fine of not more than \$5,000.00. Upon a third or subsequent conviction of highjacking a motor vehicle in the 38 39 second degree, a person shall be punished by imprisonment for not less than five nor 40 more than 20 years and a fine of not more than \$5,000.00. (d) The offense of hijacking a motor vehicle in the first degree shall be considered a 41 separate offense and shall not merge with any other offense; and the punishment prescribed 42 43 by subsection (c) of this Code section shall not be deferred, suspended, or probated."

Said title is further amended by revising subsection (c) of Code Section 16-7-1, relating to burglary, as follows:

"(c) A person commits the offense of burglary in the second degree when, without authority and with the intent to commit a felony or theft therein, he or she enters or remains within an occupied, unoccupied, or vacant building, structure, vehicle, railroad car, watercraft, or aircraft. A person who commits the offense of burglary in the second degree shall be guilty of a felony and, upon conviction thereof, shall be punished by imprisonment for not less than one nor more than five years. Upon the second and all subsequent convictions for burglary in the second degree, the defendant shall be guilty of a felony and shall be punished by imprisonment for not less than one nor more than eight years."

- vehicle" with "highjacking a motor vehicle in the first degree" in the following:

- 61 (2) Subparagraph (b)(1)(L) of Code Section 15-11-505, relating to use of detention
- assessments to determine if detention is warranted and "serious delinquent act" defined;

69 Code Section 16-11-131 of the Official Code of Georgia Annotated, relating to possession

of a firearm by convicted felons and first-offender probationers, is amended by revising

- 72 "(e) As used in this Code section, the term 'forcible felony' means any felony which
- involves the use or threat of physical force or violence against any person and further
- includes, without limitation, murder; murder in the second degree; burglary in any degree;
- robbery; armed robbery; home invasion in any degree; kidnapping; hijacking of an aircraft
- or <u>highjacking a</u> motor vehicle <u>in the first degree</u>; aggravated stalking; rape; aggravated
- child molestation; aggravated sexual battery; arson in the first degree; the manufacturing,
- 78 transporting, distribution, or possession of explosives with intent to kill, injure, or
- 79 intimidate individuals or destroy a public building; terroristic threats; or acts of treason or
- 80 insurrection."

81 **SECTION 3-2.**

- 82 Title 17 of the Official Code of Georgia Annotated, relating to criminal procedure, is
- 83 amended by revising division (a)(11)(A)(vi) of Code Section 17-7-130, relating to
- 84 proceedings upon plea of mental incompetence to stand trial, as follows:
- 85 "(vi) Hijacking of a motor vehicle in the first degree or highjacking an aircraft;"

86 **SECTION 3-3.**

- 87 Said title is further amended by revising paragraph (6) of subsection (a) of Code Section
- 88 17-10-9.1, relating to voluntary surrender to county jail or correctional institution, as follows:
- 89 "(6) Aircraft hijacking and hijacking of a motor vehicle in the first degree;"
