3 FOR the purpose of altering the process by which a person who is denied a certain handgun permit or renewal of a permit or whose permit is revoked or limited by the Secretary 4 of State Police or the Secretary's designee may appeal the decision; repealing $\mathbf{5}$ 6 provisions of law relating to the Handgun Permit Review Board; providing that 7 appeals from a certain decision by the Secretary or the Secretary's designee may be 8 made to the Office of Administrative Hearings in a certain manner; providing that a 9 person whose application for a certain permit or renewal of a permit is not acted on 10 by the Secretary within a certain period may request a certain hearing before the Office of Administrative Hearings; making conforming changes; and generally 11 12relating to handgun permits.

7 (a) A person who is denied a permit or renewal of a permit or whose permit is 8 revoked or limited may request the Secretary to conduct an informal review by filing a 9 written request within 10 days after receipt of written notice of the Secretary's initial 10 action.

(a) (1) A person who is denied a permit or renewal of a permit or whose permit is revoked or limited may request [the Board to review] TO APPEAL the decision of the Secretary TO THE OFFICE OF ADMINISTRATIVE HEARINGS by filing a written request with the [Board] SECRETARY within 10 days after receipt of written notice of the Secretary's final action.

26 (2) A person whose application for a permit or renewal of a permit is not 27 acted on by the Secretary within 90 days after submitting the application to the Secretary 28 may request a hearing before the [Board] **OFFICE OF ADMINISTRATIVE HEARINGS** by 29 filing a written request with the [Board] **SECRETARY**.
