- 2 (a) A dealer or other person may not be a knowing participant in a straw purchase 3 of a regulated firearm for a minor or for a person prohibited by law from possessing a 4 regulated firearm.
- 5 (b) A person who violates this section is guilty of a misdemeanor and on conviction 6 is subject to imprisonment not exceeding 10 years or a fine not exceeding \$25,000 or both.
- 7 (c) Each violation of this section is a separate crime.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 October 1, 2023.
