1.7	Section 1. Minnesota Statutes 2014, section 177.24, subdivision 1, is amended to read:
1.8	Subdivision 1. Amount. (a) For purposes of this subdivision, the terms defined in
1.9	this paragraph have the meanings given them.
1.10	(1) "Large employer" means an enterprise whose annual gross volume of sales
1.11	made or business done is not less than \$500,000 (exclusive of excise taxes at the retail
1.12	level that are separately stated) and covered by the Minnesota Fair Labor Standards Act,

1.14	(2) "Small employer" means an enterprise whose annual gross volume of sales made
1.15	or business done is less than \$500,000 (exclusive of excise taxes at the retail level that

3.5	hour for the workweek; or

issued by the Conference Board; and seasonally adjusted Minnesota unemployment rates, 4.1 indicate the potential for a substantial downturn in the state's economy. Prior to issuing 4.2 an order, the commissioner shall also calculate and consider the ratio of the rate of the 4.3 calculated change in the minimum wage rate to the rate of change in state median income 4.4 over the same time period used to calculate the change in wage rate. Prior to issuing the 4.5 order, the commissioner shall hold a public hearing, notice of which must be published in 4.6 the State Register, on the department's Web site, in newspapers of general circulation, and 4.7 by other means likely to inform interested persons of the hearing, at least ten days prior to 4.8 the hearing. The commissioner must allow interested persons to submit written comments 4.9 to the commissioner before the public hearing and for 20 days after the public hearing. 4.10

(2) The commissioner may in a year subsequent to issuing an order under clause (1), 4.11 make a supplemental increase in the minimum wage rate in addition to the increase for 4.12 a year calculated under paragraph (f). If the 4.14 supplemental increase is not the full amount, the commissioner may make a supplemental 4.15 increase of the difference, or any part of a difference, in a subsequent year until the full 4.16 amount of the increase ordered not to take effect has been included in a supplemental 4.17 increase. In making a determination to award a supplemental increase under this clause, 4.18the commissioner shall use the same considerations and use the same process as for an 4.19 order under clause (1). APPENDIX Repealed Minnesota Statutes: H1027-2

177.24 PAYMENT OF MINIMUM WAGES.

Subd. 2. Gratuities not applied. No employer may directly or indirectly credit, apply, or utilize gratuities towards payment of the minimum wage set by this section or federal law.
