21	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

23	NEW SECTION. Section 1. Short title. [Sections 1 through 13], [sections 14 through 17], and [section
24	19] may be cited as the "Montana Health and Economic Livelihood Partnership (HELP) Act".
25	
26	NEW SECTION. Section 2. Montana HELP Act program legislative findings and purpose. (1)
27	There is a Montana Health and Economic Livelihood Partnership Act program established through a collaborative
28	effort of the department of public health and human services and the department of labor and industry to:
29	(a) provide coverage of health care services for low-income Montanans;
30	(b) improve the readiness of program participants to enter the workforce or obtain better-paying jobs;

2	(c) reduce the dependence of Montanans on public assistance programs.
3	(2) The legislature finds that improving the delivery of health care services to Montanans requires state
4	government, health care providers, patient advocates, and other parties interested in high-quality, affordable
5	health care to collaborate in order to:
6	(a) increase the availability of high-quality health care to Montanans;
7	(b) provide greater value for the tax dollars spent on the Montana medicaid program;
8	(c) reduce health care costs;
9	(d) provide incentives that encourage Montanans to take greater responsibility for their personal health;
10	(e) boost Montana's economy by reducing the costs of uncompensated care; and
11	(f) reduce or minimize the shifting of payment for unreimbursed health care costs to patients with health
12	insurance.
13	(3) The legislature further finds that providing greater value for the dollars spent on the medicaid program
14	requires considering options for delivering services in a more efficient and cost-effective manner, including but
15	not limited to:
16	(a) offering incentives to encourage health care providers to achieve measurable performance outcomes;
17	(b) improving the coordination of care among health care providers who participate in the medicaid
18	program;
19	(c) reducing preventable hospital readmissions; and
20	(d) exploring methods of medicaid payment that promote quality of care and efficiencies.
21	(4) The legislature further finds that assessing workforce readiness and providing necessary job training
22	or skill development for individuals who need assistance with health care costs could help those individuals obtain
23	employment that has health care coverage benefits or that would allow them to purchase their own health
24	insurance coverage.
25	(5) The legislature further finds that:
26	(a) it is important to implement additional fraud, waste, and abuse safeguards to protect and preserve
27	the integrity of the medicaid program and the unemployment insurance program for individuals who qualify for
28	the programs; and
29	(b) state policymakers have an interest in testing the effectiveness of wellness incentives in order to
30	collect and analyze information about the correlation between wellness incentives and health status.

1 (6) The purposes of the act are to: 2 (a) modify and enhance Montana's health care delivery system to provide access to high-quality, 3 affordable health care for all Montana citizens; and 4 (b) provide low-income Montanans with opportunities to improve their readiness for work or to obtain 5 higher-paying jobs. 6 (7) The department of labor and industry and the department of public health and human services shall 7 maximize the use of existing resources in administering the program. 8 9 NEW SECTION. Section 3. Definitions. Section 4. Montana HELP Act program -- eligibility for coverage of health care 21 services- -- STATUTORY APPROPRIATIONS -- FEDERAL SPECIAL REVENUE. (1) An individual is eligible for coverage 22 of health care services provided pursuant to [sections 1 through 13] if the individual meets the requirements of 23 42 U.S.C. 1396a(a)(10)(A)(i)(VIII). 24 (2) FUNDS NECESSARY TO IMPLEMENT [SECTIONS 1 THROUGH 13], INCLUDING BENEFITS AND ADMINISTRATIVE 25 COSTS, ARE STATUTORILY APPROPRIATED, AS PROVIDED IN 17-7-502, FROM THE GENERAL FUND TO THE DEPARTMENT 26 OF PUBLIC HEALTH AND HUMAN SERVICES. 27 (3) THERE IS AN ACCOUNT IN THE FEDERAL SPECIAL REVENUE FUND TO THE CREDIT OF THE DEPARTMENT OF 28 PUBLIC HEALTH AND HUMAN SERVICES FOR THE PAYMENT OF COSTS, INCLUDING BENEFITS AND ADMINISTRATIVE COSTS, 29 OF PROVIDING HEALTH CARE SERVICES TO INDIVIDUALS WHO ARE ELIGIBLE FOR COVERAGE PURSUANT TO SUBSECTION 30 (1).

6	NEW SECTION. Section 5. Montana HELP Act program delivery of health care services

9	members eligible under [section 4], including but not limited to:
10	(a) establishing networks of health care providers;
11	(b) paying claims submitted by health care providers;
12	(c) collecting the premiums provided for in [section 7];
13	(d) coordinating care; <del>and</del>
14	(e) helping to administer the program as directed by the department; AND
15	(F) HELPING TO ADMINISTER THE MEDICAID PROGRAM REFORMS AS SPECIFIED IN [SECTION 8].
16	(2) The department shall determine the basic health care services to be provided through the
17	arrangement with a third-party administrator.
18	(3) (a) The department may exempt certain individuals who are eligible for medicaid-funded services
19	pursuant to [section 4] from receiving health care services through the arrangement with a third-party
20	administrator if the individuals would be served more appropriately through the medical assistance program
21	established in Title 53, chapter 6, part 1, because the individuals:
22	(i) have exceptional health care needs, including but not limited to medical, mental health, or
23	developmental conditions;
24	(ii) live in a geographical area, including an Indian reservation, for which the third-party administrator has

4 (4) For members participating in the arrangement with the third-party administrator, the department shall
5 directly cover any service required under federal or state law that is not available through the arrangement with
6 the third-party administrator.

(5) The department shall:

8 (a) seek federal authorization from the U.S. department of health and human services through a waiver 9 authorized by 42 U.S.C. 1315 and other waivers or through other means, as may be necessary, to implement 10 all of the provisions of [sections 1 through 13] and [sections 14 through 17]; and

11 (b) implement access to the health care services in accordance with the requirements necessary to

12 receive the federal medical assistance percentage provided for by 42 U.S.C. 1396d(y).

- (6) The department may provide medicaid-funded services to members eligible pursuant to [section 4]only upon federal approval of any necessary waivers.

16 <u>NEW SECTION.</u> Section 6. Copayments -- exemptions -- report. (1) A program participant shall make
 17 copayments to health care providers for health care services received pursuant to [sections 1 through 13].

(2) Except as provided in subsection (3), the department shall adopt a copayment schedule that reflects
the maximum copayment amount allowed under federal law. The total amount of copayments collected under
this section must be capped at the maximum amount allowed by federal law and regulations.

- 21 (3) The department may not require a copayment for:
- 22 (a) preventive health care services;
- 23 (b) generic pharmaceutical drugs;
- 24 (c) immunizations provided according to a schedule established by the department that reflects 25 guidelines issued by the centers for disease control and prevention; or
- 26 (d) medically necessary health screenings ordered by a health care provider.
- 27 (4) Each health care provider participating in the third-party arrangement shall report the following
- 28 information annually to the oversight committee on the Montana Health and Economic Livelihood Partnership Act:
- 29 (a) the total amount of copayments that the provider was unable to collect from participants; and
- 30 (b) the efforts the health care provider made to collect the copayments.

2 <u>NEW SECTION.</u> Section 7. Premiums -- collection of overdue premiums -- nonpayment as 3 voluntary disenrollment -- reenrollment -- exemptions. (1) (a) A program participant shall pay an annual premium, billed monthly, equal to 2% of the participant's income as determined in accordance with 42 U.S.C. 4 5 1396a(e)(14). 6 (b) Premiums paid pursuant to this section must be deposited in the general fund. 7 (2) Within 30 days of a participant's failure to make a required payment, the third-party administrator shall 8 notify the participant and the department that payment is overdue and that all overdue premiums must be paid 9 within 90 days of the date the notification was sent. 10 (3) (a) If a participant with an income of 100% of the federal poverty level or less fails to make payment 11 for overdue premiums, the department shall provide notice to the department of revenue of the participant's failure 12 to pay. The department of revenue shall collect the amount due for nonpayment by assessing the amount against 13 the participant's annual income tax in accordance with Title 15, chapters 1 and 30. 14 (b) The debt remains until paid and may be collected through assessments against future income tax 15 returns or through a civil action initiated by the state. 16 (4) If a participant with an income of more than 100% but not more than 138% of the federal poverty level 17 fails to make the overdue payments within 90 days of the date the notification was sent, the department shall: 18 (a) follow the procedure established in subsection (3) for collection of the unpaid premiums; and 19 (b) consider the failure to pay to be a voluntary disenrollment from the program. The department may 20 reenroll a participant in the program upon payment of the total amount of overdue payments. 21 (5) If a participant who has failed to pay the premiums does not indicate that the participant no longer 22 wishes to participate in the program, the department may reenroll the person in the program when the department 23 of revenue assesses the unpaid premium through the participant's income taxes. 24 (6) Participants who meet two of the following criteria are not subject to the voluntary disenrollment 25 provisions of this section: 26 (a) discharge from United States military service within the previous 12 months; 27 (b) enrollment for credit in any Montana university system unit, a tribal college, or any other accredited 28 college within Montana offering at least an associate degree, subject to the provisions of subsection (7); 29 (c) participation in a workforce program or activity established under [sections 14 through 17]; or 30 (d) participation in any of the following healthy behavior plans developed by a primary care HEALTH CARE Legislative Services - 6 -Authorized Print Version - SB 405 Division

provider OR THIRD-PARTY ADMINISTRATOR or approved by the department: 1 2 (i) a medicaid health home; 3 (ii) a patient-centered medical home; 4 (iii) a cardiovascular disease, obesity, or diabetes prevention program; 5 (iv) a program restricting the participant to obtaining primary care services from a designated provider 6 and obtaining prescriptions from a designated pharmacy; 7 (v) a medicaid primary care case management program established by the department; 8 (vi) a tobacco use prevention or cessation program; 9 (vii) a medicaid waiver program providing coverage for family planning services; 10 (viii) a substance abuse treatment program; or 11 (ix) a care coordination or health improvement plan administered by the third-party administrator. 12 (7) A participant seeking an exemption under subsection (6) is not eligible for the education exemption 13 provided for in subsection (6)(b) for more than 4 years. 14 15 NEW SECTION. Section 8. Medicaid program reforms. (1) To ensure that the Montana medicaid 16 program is administered efficiently and effectively, the department shall strengthen existing programs that 17 manage the way members obtain approval for medical services and shall establish additional programs designed 18 to reduce costs and improve medical outcomes. The efforts may include but are not limited to: 19 (a) establishing by rule requirements designed to strengthen the relationship between physicians and 20 members enrolled in existing primary care case management programs; 21 (b) strengthening data-sharing arrangements with providers to reduce inappropriate use of emergency 22 room services and overuse of other services; 23 (c) expanding to additional members any existing programs in which case managers and providers work 24 with members with high-risk medical conditions to provide preventive care and advice and to make referrals for 25 medical services; 26 (d) establishing, within existing funds, one or more pilot programs to improve the health of members, 27 including but not limited to efforts to increase pain management, decrease emergency department overuse, and 28 prevent drug or alcohol addiction or abuse; 29 (e) reviewing existing primary care case management programs to evaluate and improve their 30 effectiveness: Legislative - 7 -Authorized Print Version - SB 405 ervices

Section 9. Health care services payment schedules. (1) The department of 22 corrections, AND the department of public health and human services, and local governments shall reimburse 23 health care service for individuals identified in subsection (2) at the rates adopted by the department for the 24 medicaid program under Title 53, chapter 6, part 1, if the health care services are not otherwise covered by 25 medicaid, medicare, a health insurer, or another private or governmental program that pays for health care costs. 26 (2) This section applies to individuals: 27 (a) in the custody of the department of corrections; OR 28 (b) in the custody of a local government law enforcement agency; 29 (c) receiving mental health services from a local government; or 30 (d)(B) who are residents, by commitment or otherwise, of the Montana state hospital, the Montana mental Legislative

3	NEW SECTION. Section 10. Reduction in federal medical assistance percentage. If the federal
4	medical assistance percentage for medical services provided to individuals eligible for medicaid-funded services
5	pursuant to [section 4] is set below the levels established in 42 U.S.C. 1396d(y)(1) on [the effective date of this
6	act], the continuation of coverage under [sections 1 through 13] is contingent on:
7	(1) the appropriation of additional state general fund or other action by the legislature;
8	(2) the ability of the department to increase premiums assessed under [section 7] to pay the difference;

20	minority leader; and
21	(c) five individuals appointed by the governor as follows:
22	(i) one representative of a hospital as defined in 50-5-101;
23	(ii) one representative of a critical access hospital as defined in 50-5-101;
24	(iii) one primary care physician;
25	(iv) one representative of the state auditor's office; and
26	(v) one member of the general public or a staff member of the governor's office.
27	(3) The state medicaid director or the director's designee, the commissioner of labor and industry or the
28	commissioner's designee, and a designee of the third-party administrator are ex officio members of the
29	committee.
30	(4) The presiding officer and vice presiding officer must be elected by a majority of the committee

2	(5) The presiding officer shall establish the meeting schedule. The council shall meet at least quarterly.
3	(6) (a) Except as provided in subsection (6)(b), members are entitled to receive compensation and
4	expenses as provided in 5-2-302.
5	(b) Ex officio members are not entitled to compensation or reimbursement of expenses.
6	(7) (a) Except as provided in subsection (7)(b), members shall serve 4-year terms. Vacancies on the
7	committee must be filled by the same appointing authority.
8	(b) A member who was appointed while a senator or a representative but who is no longer serving in
9	the legislature must be replaced by the appointing authority.
10	(8) The committee is attached to the department for administrative purposes, including staffing.
11	(9) The committee may contract for services that will help members carry out their duties, subject to
12	available funding and in accordance with the provisions of Title 18, chapter 4.
13	
14	NEW SECTION. Section 12. Duties of Montana HELP Act oversight committee reports. (1) To
15	provide reports and make recommendations to the legislature, the oversight committee on the Montana Health
16	and Economic Livelihood Partnership Act shall review:
17	(a) data from and activities by the department of public health and human services and the department
18	of labor and industry related to the health care and workforce development activities undertaken pursuant to the
19	HELP Act;
20	(b) the Montana medicaid program; and
21	(c) the delivery of health care services in Montana.
22	(2) The departments shall report the following information to the oversight committee quarterly:
23	(a) the number of individuals who were determined eligible for medicaid-funded services pursuant to
24	[section 4];
25	(b) demographic information on program participants;
26	(c) the average length of time that participants remained eligible for medical assistance;
27	(d) the number of participants who completed an employment or reemployment assessment;
28	(e) the number of participants who took part in workforce development activities;
29	(f) the number of participants subject to the fee provided for in [section 18] and the total amount of fees
30	collected;
