Prescriptions for controlled substances must meet the requirements of sections 28-414 and 28-414.01. 23

24 (3) A written, signed paper prescription may be transmitted to the 25 pharmacy via facsimile which shall serve as the original written 26 prescription. An electronic prescription may be electronically or 27 digitally signed and transmitted to the pharmacy and may serve as the 28 original prescription.

(4) It shall be unlawful for any person knowingly or intentionally
 to possess or to acquire or obtain or to attempt to acquire or obtain, by
 means of misrepresentation, fraud, forgery, deception, or subterfuge,

possession of any drug substance not classified as a controlled substance under the Uniform Controlled Substances Act which can only be lawfully dispensed, under federal statutes in effect on January 1, 2015, upon the written or oral prescription of a practitioner authorized to prescribe such substances.

6 Sec. 23. <u>(1) Any prescription for a legend drug which is not a</u> 7 <u>controlled substance shall be kept by the pharmacy or the practitioner</u> 8 <u>who holds a pharmacy license in a readily retrievable format and shall be</u> 9 <u>maintained for a minimum of five years. The pharmacy or practitioner</u> 10 <u>shall make all such files readily available to the department and law</u> 11 <u>enforcement for inspection without a search warrant.</u>

The record shall in 19 every case show the proportion of morphine, cocaine, or ecgonine 20 contained in or producible from crude opium or coca leaves received or 21 produced. The record of all controlled substances sold, administered, 22 23 dispensed, or otherwise disposed of shall show the date of selling, 24 administering, or dispensing, the name and address of the person to whom or for whose use or the owner and species of animal for which the 25 controlled substances were sold, administered, or dispensed, and the kind 26 and quantity of controlled substances. For any lost, destroyed, or stolen 27 28 controlled substances, the record shall list the kind and quantity of such controlled substances and the discovery date of such loss, 29 destruction, or theft. Every such record shall be kept for a period of 30 five years from the date of the transaction recorded. 31
