## A BILL

1	FOR AN ACT	relating to the Game Law; to amend sections 37-304,
2		37-321, 37-422, 37-4,107, 37-543, 37-546, and 37-604,
3		Reissue Revised Statutes of Nebraska, and sections
4		37-314, 37-447, 37-448, 37-455, 37-490, 37-492, 37-501,
5		37-503, and 37-614, Revised Statutes Cumulative
6		Supplement, 2012; to provide and change powers and duties
7		of the Game and Parks Commission regarding rules and
8		regulations; to authorize commission orders; to harmonize
9		provisions; and to repeal the original sections.

10 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 37-304, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 37-304 (1) The commission may adopt and promulgate rules
- 4 and regulations, under the procedures set forth in the Administrative
- 5 Procedure Act, governing the administration and use of all property,
- 6 real and personal, under its ownership or control.
- 7 (2) The commission shall adopt and promulgate rules and
- 8 regulations it deems necessary to administer the activities and
- 9 facilities described in sections 37-305 to 37-313.
- 10 (3) The commission may pass, by majority vote, commission
- 11 orders which govern (a) conservation orders, (b) seasons, (c) open
- 12 and closed areas, and (d) bag limits as described in section 37-314.
- 13 Sec. 2. Section 37-314, Revised Statutes Cumulative
- 14 Supplement, 2012, is amended to read:
- 15 37-314 (1) The commission may, in accordance with the
- 16 Game Law, other provisions of law, and lawful rules and regulations,
- 17 fix, prescribe, and publish rules and regulations as to open seasons
- 18 and closed seasons, either permanent or temporary, as to conservation
- 19 orders or similar wildlife management activities authorized by the
- 20 United States Fish and Wildlife Service, as to bag limits or
- 21 regarding the methods or type, kind, and specifications of hunting,
- 22 fur-harvesting, or fishing gear used in the taking of any game, game
- 23 fish, nongame fish, game animals, fur-bearing animals, or game
- 24 birds. , as to the age, sex, species, or area of the state in which
- 25 any game, game fish, nongame fish, game animals, fur-bearing animals,

1 or game birds may be taken, or as to the taking of any particular 2 kinds, species, or sizes of game, game fish, nongame fish, game 3 animals, fur bearing animals, and game birds in any designated waters 4 or areas of this state after due investigation and having due regard 5 to the distribution, abundance, economic value, breeding habits, 6 migratory habits, and causes of depletion or extermination of the 7 same in such designated waters or areas and having due regard to the 8 volume of the hunting, fur harvesting, and fishing practiced therein 9 and the climatic, seasonal, and other conditions affecting the 10 protection, preservation, and propagation of the same in such waters or areas. Such rules and regulations may be amended, modified, or 11 12 repealed from time to time, subject to such limitations and 13 standards, and such rules and regulations and all amendments, modifications, and repeals thereof and shall be based upon 14 15 investigation and available but reliable data relative to such 16 limitations and standards. (2) The commission may, in accordance with the Game Law, 17 other provisions of law, and lawful rules and regulations, pass and 18 publish commission orders regarding (a) conservation orders 19 20 authorized by the United States Fish and Wildlife Service, (b) open 21 seasons and closed seasons, either permanent or temporary, (c) bag 22 limits, including the age, sex, species, or area of the state in which any game, game fish, nongame fish, game animals, fur-bearing 23 animals, or game birds may be taken, or (d) the taking of any 24 25 particular kinds, species, or sizes of game, game fish, nongame fish,

game animals, fur-bearing animals, and game birds in any designated 1 waters or areas of this state. The commission may pass such 2 3 commission orders after due investigation and having due regard to the distribution, abundance, economic value, breeding habits, 4 5 migratory habits, and causes of depletion or extermination of the 6 same in such designated waters or areas and having due regard to the 7 volume of the hunting, fur harvesting, and fishing practiced therein 8 and the climatic, seasonal, and other conditions affecting the 9 protection, preservation, and propagation of the same in such waters 10 or areas. The commission orders may be amended, modified, or repealed 11 from time to time. Commission orders shall be based upon 12 investigation and available but reliable data relative to such 13 limitations and standards. 14 (3) The commission shall hold at least one public hearing in accordance with section 37-104 on each proposed commission order 15 16 or amendment, modification, or repeal of a commission order and shall 17 hold at least one public hearing in accordance with section 37-104, in addition to all other requirements of the Administrative Procedure 18 19 Act, on each proposed rule and regulation or amendment, modification, 20 or repeal of a rule or regulation. The commission shall give notice 2.1 of such hearing to the public at least thirty days prior to the 22 hearing by posting it on the commission's web site. No commission order shall be valid against any person until fifteen days after such 23 24 order has been posted on the commission's web site. Each such rule, regulation, amendment, modification, and repeal shall specify the 25

1 date when it shall become effective and while it remains in effect

2 shall have the force and effect of law.

3 (3) Regardless of the provisions of this section or of other sections provisions of the Game Law which empower the 4 5 commission to set seasons on game birds, fish, or animals or provide 6 the means and method by which such seasons are set or promulgated and 7 regardless of the provisions of the Administrative Procedure Act, the 8 commission may close or reopen any open season previously set on game 9 birds, fish, or animals in all or any specific portion of the state. The commission shall only close or reopen such seasons by majority 10 vote at a valid special meeting called under section 37-104 and other 11 12 provisions of statutes regarding the holding of public meetings. Any 13 closing or reopening of an open season previously set by the 14 commission shall not be effective for at least twenty-four hours 15 after such action by the commission. The commission shall make every effort to make available to all forms of the news media the 16 information on any opening or closing of any open season on game 17 birds, fish, or animals previously set. The commission may only use 18 19 this special provision allowing the commission to open or close game 20 bird, fish, or animal seasons previously set in emergency situations in which the continuation of the open season would result in grave 21 danger to human life or property or to bird, fish, or wild animal 22 23 populations. The commission may also close or reopen any season established by a conservation order under the same provisions 24

pertaining to closing and reopening seasons in this section.

- 2 adopted and promulgated or commission orders passed pursuant to this
- 3 section shall be guilty of a Class III misdemeanor and shall be fined
- 4 at least one hundred dollars upon conviction.
- 5 Sec. 3. Section 37-321, Reissue Revised Statutes of
- 6 Nebraska, is amended to read:
- 7 37-321 The commission secretary of the commission may, by
- 8 regulation, order, authorize the taking of fish by any means and in
- 9 any number whenever the secretary of the commission determines,
- 10 pursuant to standards imposed by such regulations, rules and
- 11 regulations adopted and promulgated by the commission, that such
- 12 action is necessary for proper fish management as a result of an
- 13 emergency created by the drying up of any waters inhabited by fish.
- 14 Such determination shall specify the waters in which such emergency
- 15 action is desirable, and the authorization so granted shall extend to
- 16 such waters and to no others. The taking of any fish in violation of
- 17 this section shall be a Class V misdemeanor.

- 21 fishing permits on areas designated by it and subject to intensive
- 22 fishery management. Such permits may be vended by mechanical or
- 23 electronic methods. The commission may establish the fee, form, and
- 24 requirements of such special daily fishing permit, and establish
- 25 rules and regulations and commission orders pursuant to section

1 <u>37-314</u> governing seasons, limits, methods of taking, open or closed

- 2 waters, and such other regulations <u>and commission orders</u> as it deems
- 3 necessary on such designated areas. Such special daily fishing permit
- 4 shall be required of any and all persons fishing on the designated
- 5 area and shall be the only fishing permit required thereon. The
- 6 commission may only issue the permits authorized by this section on
- 7 staffed areas or on portions of staffed areas under its ownership or
- 8 control which are intensively managed or stocked for a high level of
- 9 fish production.
- 10 (2) An educational fishing project permit may be issued
- 11 to any instructor of a university, college, or high school and his or

- 15 in the project. Such exemption shall not extend to the privilege of
- 16 commercial fishing or to the privilege of fishing for any species of
- 17 fish on which an open season is limited to a restricted number of
- 18 permits or to special permits for a restricted area. The commission
- 19 shall adopt and promulgate rules and regulations necessary to carry
- 20 out this subsection.
- 21 Sec. 5. Section 37-447, Revised Statutes Cumulative
- 22 Supplement, 2012, is amended to read:
- 23 37-447 (1) The commission may issue permits for the
- 24 hunting of deer and prescribe—and adopt and promulgate rules and
- 25 regulations and pass commission orders pursuant to section 37-314 to

prescribe limitations for the hunting, transportation, and possession 1 2 The commission may offer multiple-year permits of deer. 3 combinations of permits at reduced rates. The commission may specify 4 by rule and regulation the information to be required on applications 5 for such permits. Regulations and limitations Rules and regulations for the hunting, transportation, and possession of deer may include, 6 7 but not be limited to, <u>rules and</u> regulations <del>and limitations</del> as to 8 caliber, and other specifications of firearms the type, 9 ammunition used and specifications for bows and arrows used. Such rules and regulations and limitations may further specify and limit 10 the method of hunting deer and may provide for dividing the state 11 12 into management units or areas, and the commission may enact 13 different deer hunting regulations for the different management units pertaining to sex, species, and age of the deer hunted. 14 15 (2) The number of such permits may be limited as provided 16 by the rules and regulations of the commission, and except as provided in section 37-454, the permits shall be disposed of in an 17 18 impartial manner. Whenever the commission deems it advisable to limit

impartial manner. Whenever the commission deems it advisable to limit the number of permits issued for any or all management units, the commission shall, by rules and regulations, determine who shall be eligible to obtain such permits. In establishing eligibility, the commission may give preference to persons who did not receive a permit or a specified type of permit during the previous year or years.

(3) Such permits may be issued to allow deer hunting in

1 the Nebraska National Forest and other game reserves and such other

- 2 areas as the commission may designate whenever the commission deems
- 3 that permitting such hunting will not be detrimental to the proper
- 4 preservation of wildlife in Nebraska in such forest, reserves, or
- 5 areas.
- 6 (4)(a) The commission shall, pursuant to section 37-327,
- 7 establish and charge a fee of not more than twenty-nine dollars for
- 8 residents and not more than two hundred fourteen dollars for
- 9 nonresidents for each permit issued under this section except as
- 10 otherwise provided in subdivision (b) of this subsection and
- 11 subsection (6) of this section.
- 12 (b) The fee for a statewide buck-only permit shall be no
- more than two and one-half times the amount of a regular deer permit.
- 14 The commission may provide different fees for different species.
- 15 (5) The commission may issue nonresident permits after
- 16 preference has been given for the issuance of resident permits as
- 17 provided in rules and regulations adopted and promulgated by the
- 18 commission. The commission may require a predetermined application
- 19 period for permit applications in specified management units. Such
- 20 permits shall be issued after a reasonable period for making
- 21 application, as established by the commission, has expired. When more
- 22 valid applications are received for a designated management unit than
- 23 there are permits available, such permits shall be allocated on the
- 24 basis of a random drawing. All valid applications received during the
- 25 predetermined application period shall be considered equally in any

1 such random drawing without regard to time of receipt of such

- 2 applications by the commission.
- 3 (6) The commission shall, pursuant to section 37-327,
- 4 establish and charge a fee of not more than twenty-five dollars for
- 5 residents and not more than forty-five dollars for nonresidents for a
- 6 youth deer permit.
- 7 (7) Any person violating the rules and regulations
- 8 adopted and promulgated or commission orders passed pursuant to this
- 9 section shall be guilty of a Class II misdemeanor and shall be fined
- 10 at least one hundred dollars upon conviction.
- 11 Sec. 6. Section 37-448, Revised Statutes Cumulative
- 12 Supplement, 2012, is amended to read:
- 13 37-448 (1) Subject to rules and regulations adopted and
- 14 promulgated by the commission, the secretary of the commission may
- 15 designate, by order, special deer depredation seasons or extensions
- 16 of existing deer hunting seasons. by executive order. The secretary
- 17 may designate a depredation season or an extension of an existing
- 18 deer hunting season whenever he or she determines that deer are
- 19 causing excessive property damage. The secretary shall specify the
- 20 number of permits to be issued, the species of deer allowed to be
- 21 taken, the bag limit for such species including deer for donation in
- 22 accordance with the deer donation program established pursuant to
- 23 sections 37-1501 to 37-1510, the beginning and ending dates for the
- 24 depredation season or hunting season extension, shooting hours, the
- 25 length of the depredation season or hunting season extension, and the

1 geographic area in which hunting will be permitted. Hunting during a

- 2 special depredation season or hunting season extension shall be
- 3 limited to residents, and the rules and regulations shall allow use

- 8 manner at a location determined by the secretary. The commission
- 9 shall, pursuant to section 37-327, establish and charge a fee of not
- 10 more than twenty-five dollars for a special depredation season
- 11 permit. The commission shall use the income from the sale of special
- 12 depredation season permits for abatement of damage caused by deer.
- 13 The commission shall also provide for an unlimited number of free
- 14 permits for the taking of antlerless deer upon request to any person
- 15 owning or operating at least twenty acres of farm or ranch land
- 16 within the geographic area in which hunting will be permitted and to
- 17 any member of the immediate family of any such person as defined in
- 18 subdivision (2)(a) of section 37-455. A free permit shall be valid
- 19 only within such area and only during the designated deer depredation
- 20 season. Receipt of a depredation season permit shall not in any way
- 21 affect a person's eligibility for a regular season permit.
- 22 Sec. 7. Section 37-455, Revised Statutes Cumulative
- 23 Supplement, 2012, is amended to read:
- 24 37-455 (1) The commission may issue a limited permit for
- 25 deer, antelope, wild turkey, or elk to a person who is a qualifying

landowner or leaseholder and his or her immediate family as described 1 2 in this section. The commission may issue nonresident landowner 3 limited permits after preference has been given for the issuance of resident permits as provided in rules and regulations adopted and 4 5 promulgated by the commission. A permit shall be valid during the predetermined period established by the commission pursuant to 6 7 sections 37-447 to 37-450, 37-452, 37-456, or 37-457. Upon receipt of 8 an application in proper form as prescribed by the rules and regulations of the commission, the commission may issue (a) a limited 9 deer, antelope, or wild turkey permit valid for hunting on all of the 10 11 land which is owned or leased by the qualifying landowner or 12 leaseholder if such lands are identified in the application or (b) a 13 limited elk permit valid for hunting on the entire elk management 14 unit of which the land of the qualifying landowner or leaseholder 15 included in the application is a part. 16 (2)(a) The commission shall adopt and promulgate rules regulations prescribing procedures 17 and forms and create requirements for documentation by an applicant or permittee to 18 19 determine whether the applicant or permittee is a Nebraska resident 20 and is a qualifying landowner or leaseholder of the described 21 property or is a member of the immediate family of such qualifying landowner or leaseholder. Only a person who is a qualifying landowner 22 23 or leaseholder and such person's immediate family may apply for a 24 limited permit. An applicant may apply for no more than one permit per species per year except as otherwise provided in the rules and 25

1 regulations of the commission. For purposes of this section,

- 2 immediate family means and is limited to a husband and wife and their
- 3 children or siblings sharing ownership in the property.
- 4 (b) The conditions applicable to permits issued pursuant
- 5 to sections 37-447 to 37-450, 37-452, 37-456, or 37-457, whichever is
- 6 appropriate, shall apply to limited permits issued pursuant to this
- 7 section, except that the commission may adopt and promulgate rules
- 8 and regulations pass commission orders for species harvest allocation
- 9 pertaining to the sex and age of the species harvested which are
- 10 different for a limited permit than for other hunting permits. For
- 11 purposes of this section, white-tailed deer and mule deer shall be
- 12 treated as one species.
- 13 (3)(a) To qualify for a limited permit to hunt deer or
- 14 antelope, the applicant shall be a Nebraska resident who owns or
- 15 leases eighty acres or more of farm or ranch land for agricultural
- 16 purposes or a member of such person's immediate family. The number of
- 17 limited permits issued annually per species for each farm or ranch
- 18 shall not exceed the total acreage of the farm or ranch divided by
- 19 eighty. The fee for a limited permit to hunt deer or antelope shall
- 20 be one-half the fee for the regular permit for such species.
- 21 (b) A nonresident of Nebraska who owns three hundred
- 22 twenty acres or more of farm or ranch land in the State of Nebraska
- 23 for agricultural purposes or a member of such person's immediate
- 24 family may apply for a limited deer or antelope permit. The number of
- 25 limited permits issued annually per species for each farm or ranch

1 shall not exceed the total acreage of the farm or ranch divided by

- 2 three hundred twenty. The fee for such a permit to hunt deer or
- 3 antelope shall be one-half the fee for a nonresident permit to hunt
- 4 such species.
- 5 (c) The commission may adopt and promulgate rules and
- 6 regulations providing for the issuance of an additional limited deer
- 7 permit to a qualified individual for the taking of a deer without
- 8 antlers at a fee equal to or less than the fee for the original
- 9 limited permit.
- 10 (4)(a) To qualify for a limited permit to hunt wild
- 11 turkey, the applicant shall be a Nebraska resident who owns or leases
- 12 eighty acres or more of farm or ranch land for agricultural purposes
- or a member of such person's immediate family. The number of limited
- 14 permits issued annually per season for each farm or ranch shall not
- 15 exceed the total acreage of the farm or ranch divided by eighty. An
- 16 applicant may apply for no more than one limited permit per season.
- 17 The fee for a limited permit to hunt wild turkey shall be one-half
- 18 the fee for the regular permit to hunt wild turkey.
- 19 (b) A nonresident of Nebraska who owns three hundred
- 20 twenty acres or more of farm or ranch land in the State of Nebraska
- 21 for agricultural purposes or a member of such person's immediate
- 22 family may apply for a limited permit to hunt wild turkey. Only one
- 23 limited wild turkey permit per three hundred twenty acres may be
- 24 issued annually for each wild turkey season under this subdivision.
- 25 The fee for such a permit to hunt shall be one-half the fee for a

1 nonresident permit to hunt wild turkey.

2 (5) To qualify for a limited permit to hunt elk, (a) the 3 applicant shall be (i) a Nebraska resident who owns three hundred twenty acres or more of farm or ranch land for agricultural purposes, 4 5 (ii) a Nebraska resident who leases six hundred forty acres or more of farm or ranch land for agricultural purposes or has a leasehold 6 7 interest and an ownership interest in farm or ranch land used for 8 agricultural purposes which when added together totals at least six hundred forty acres, (iii) a nonresident of Nebraska who owns at 9 least one thousand two hundred eighty acres of farm or ranch land for 10 agricultural purposes, or (iv) a member of such owner's or lessee's 11 12 immediate family and (b) the qualifying farm or ranch land of the 13 applicant shall be within an area designated as an elk management 14 zone by the commission in its rules and regulations. An applicant shall not be issued a limited bull elk permit more than once every 15 three years, and the commission may give preference to a person who 16 did not receive a limited elk permit or a specified type of limited 17 elk permit during the previous years. The fee for a resident 18 landowner limited permit to hunt elk shall not exceed one-half the 19 20 fee for the regular permit to hunt elk. The fee for a nonresident landowner limited permit to hunt elk shall not exceed three times the 21 cost of a resident elk permit. The number of applications allowed for 22 23 limited elk permits for each farm or ranch shall not exceed the total acreage of the farm or ranch divided by the minimum acreage 24 requirements established for the property. No more than one person 25

- 1 may qualify for the same described property.
- 2 Sec. 8. Section 37-490, Revised Statutes Cumulative
- 3 Supplement, 2012, is amended to read:
- 4 37-490 No person shall hunt any upland game birds and
- 5 mallard ducks upon such breeding and controlled shooting area except
- 6 between September 1 and April 1 of each year, except that turkeys may
- 7 be hunted throughout the open season and dog training or dog trial
- 8 activities may be permitted as prescribed by rules and regulations of
- 9 the commission or commission orders.
- 10 Sec. 9. Section 37-492, Revised Statutes Cumulative
- 11 Supplement, 2012, is amended to read:
- 12 37-492 The commission may adopt and promulgate rules and
- 13 regulations and pass commission orders for carrying out,
- 14 administering, and enforcing the provisions of sections 37-484 to
- 15 37-496. The commission shall limit the number of areas proposed for
- 16 licensing so that the total acreage licensed for game breeding and
- 17 controlled shooting areas in any one county does not exceed two
- 18 percent of the total acreage of the county in which the areas are
- 19 sought to be licensed. The commission shall not require distances
- 20 between boundaries of game breeding and controlled shooting areas to

- 3 Sec. 13. Section 37-543, Reissue Revised Statutes of
- 4 Nebraska, is amended to read:
- 5 37-543 (1) It shall be unlawful for any person to take
- 6 any fish, except as provided in this section, by means other than
- 7 fishing with hook and line.
- 8 (2) It shall be unlawful for any person to use, while
- 9 fishing in this state in any lake, pond, or reservoir or in their
- 10 inlets, outlets, and canals within one-half mile of such lake, pond,
- 11 or reservoir, more than two lines, and neither line shall have more
- 12 than two hooks. This subsection shall not apply to ice fishing.
- 13 (3) It shall be unlawful for any person to take any fish
- 14 by snagging fish externally by hook and line, except in the Missouri
- 15 River, as provided by rules and regulations of the commission.
