AN ACT

- 1 Amending Title 64 (Public Authorities and Quasi-Public
- 2 Corporations) of the Pennsylvania Consolidated Statutes, in
- 3 Pennsylvania Convention Center Authority, further providing
- for hotel room rental tax and continuation of existing tax.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6025(j) of Title 64 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 6025. Hotel room rental tax; continuation of existing tax.
- 10 * * *
- 11 (j) Definitions.--In addition to the definitions provided by
- 12 section 6003 (relating to definitions), the following words and
- 13 phrases when used in this section shall have the meanings given
- 14 to them in this subsection unless the context clearly indicates
- 15 otherwise:
- "Consideration." Receipts, fees, charges, rentals, leases,
- 17 cash, credits, property of any kind or nature, any amount
- 18 charged by an intermediary to an occupant and retained by the
- 19 <u>intermediary</u>, or other payment, received by operators in

- 1 exchange for or in consideration of the use or occupancy by a
- 2 transient of a room or rooms in a hotel for any temporary
- 3 period.
- 4 "Hotel." As follows:
- 5 (1) Any hotel, motel, inn, guesthouse or other building
- 6 located within the city which holds itself out by any means,
- 7 including advertising, license, registration with any
- 8 innkeeper's group, convention listing association, travel
- 9 publication or similar association or with any government
- 10 agency, as being available to provide overnight lodging or
- 11 use of facility space for consideration to individuals
- 12 seeking temporary accommodation.
- 13 (2) Any place which advertises to the public at large or
- any segment of the public that it will provide beds, sanitary
- facilities or other space for a temporary period to members
- of the public at large.
- 17 (3) Any place recognized as a hostelry.
- 18 The term does not include a portion of a facility which is
- 19 devoted to individuals who have established permanent residence.
- 20 "Intermediary." A person who facilitates the booking of
- 21 hotel reservations and who is not an operator.
- 22 "Occupancy." The use or possession or the right to the use
- 23 or possession by any person other than a permanent resident of
- 24 any room in a hotel for any purpose or the right to the use or
- 25 possession of the furnishings or to the services accompanying
- 26 the use and possession of the room.
- 27 "Operator." Any individual, partnership, nonprofit or
- 28 profit-making association or corporation or other person or
- 29 group of persons that maintains, operates, manages, owns, has
- 30 custody of or otherwise possesses the right to rent or lease

- 1 overnight accommodations in a hotel to the public for
- 2 consideration.
- 3 "Patron." A person that pays the consideration for the
- 4 occupancy of a room or rooms in a hotel.
- 5 "Permanent resident." Any person who has occupied or has the
- 6 right to occupy any room or rooms in a hotel as a patron or
- 7 otherwise for a period exceeding 30 consecutive days.
- 8 "Room." A space in a hotel set aside for use and occupancy
- 9 by patrons, or otherwise, for consideration, having at least one
- 10 bed or other sleeping accommodations provided in the space.
- "Temporary." A period of time not exceeding 30 consecutive
- 12 days.
- "Tourist promotion agency." The agency designated by the
- 14 council of the city in which the convention center is located to
- 15 be eligible for grants from the Department of Community and
- 16 Economic Development [pursuant to the act of April 28, 1961
- 17 (P.L.111, No.50), known as the Tourist Promotion Law.] under the
- 18 act of July 4, 2008 (P.L.621, No.50), known as the Tourism
- 19 <u>Promotion Act</u>.
- 20 "Transaction." The activity involving the obtaining by a
- 21 transient or patron of the use or occupancy of a hotel room from
- 22 which consideration emanates to the operator under an express or
- 23 an implied contract.
- Transient." An individual who obtains an accommodation in a
- 25 hotel for the individual by means of registering at the facility
- 26 for the temporary occupancy of any room for the personal use of
- 27 that individual by paying to the operator of the facility a fee
- 28 in consideration for the use.
- 29 Section 2. This act shall take effect in 60 days.
