Amending Title 61 (Prisons and Parole) of the Pennsylvania Consolidated Statutes, in general administration, providing for secure firearm storage at State correctional 3 institutions. 4 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 7 Section 1. Title 61 of the Pennsylvania Consolidated Statutes is amended by adding a section to read: 8 9 § 1106. Secure firearm storage at State correctional 10 institutions. 11 (a) Duties. -- The department shall provide a secure storage 12 unit at a State correctional institution for the purpose of storing a personal firearm belonging to a corrections officer. 13 14 The chief administrator shall designate the location of the secure storage unit outside of the secure perimeter of the State 15 16 correctional institution. 17 (b) Carrying authorized. -- A corrections officer may carry personal firearms into a State correctional institution if all 18

of the following apply:
