House Bill 1222**AMENDMENT 1222B
FOR THE INTRODUCED BILL**

1 **An Act to expand the authorized carrying, possession, and storage of a concealed**
2 **pistol.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That § 13-32-7 be AMENDED:**

5 **13-32-7.** Any person who intentionally carries, possesses, stores, keeps, leaves,
6 places, or puts into the possession of another person, any dangerous weapon, firearm, or
7 air gun, whether or not the firearm or air gun is designed, adapted, used, or intended to
8 be used primarily for imitative or noisemaking purposes, on or in any public elementary
9 or secondary school premises, vehicle, or building, or on or in any premises, vehicle, or
10 building used or leased for public elementary or secondary school functions, whether or
11 not any person is endangered by any action under this section, is guilty of a Class 1
12 misdemeanor.

13 This section does not apply to:

- 14 (1) A law enforcement officer;
- 15 (2) An individual who has completed a school sentinel training course, in accordance
16 with chapter 13-64;
- 17 (3) An individual who:
- 18 (a) Is twenty-one years of age or older;
- 19 (b) Holds an enhanced permit to carry a concealed pistol, issued in accordance
20 with chapter 23-7; and
- 21 (c) Has written permission from the principal of the school or other person who
22 has general control and supervision of the building or grounds;
- 23 ~~(4) An individual who:~~
- 24 ~~(a) Holds a permit to carry a concealed pistol, a gold card permit to carry a~~
25 ~~concealed pistol, or an enhanced permit to carry a concealed pistol, issued~~
26 ~~in accordance with chapter 23-7; and~~

- 1 ~~(b) Carries, possesses, or stores a concealed pistol while on school property,~~
2 ~~other than in a building being used for the instruction of students;~~
- 3 (4) An individual who holds any permit to carry a concealed pistol, issued in accordance
4 with chapter 23-7, while that individual is:
- 5 (a) Inside a motor vehicle; or
6 (b) Outside a motor vehicle and securing a pistol in, or retrieving a pistol from,
7 the vehicle;
- 8 (5) The use of a starting gun at an athletic event;
- 9 ~~(5)~~(6) Any firearm or air gun at a:
- 10 (a) Firing range;
11 (b) Gun show; or
12 (c) Supervised school or session for training in the use of firearms;
- 13 ~~(6)~~(7) The ceremonial presence of an unloaded weapon at a color guard ceremony;
14 ~~(7)~~(8) A nonpublic school;
15 ~~(8)~~(9) A church or other house of worship; or
16 ~~(9)~~(10) A nonpublic school located on the premises of a church or other house of
17 worship.
