# 10 Part I 11 Repealing the Preferential B&O Tax Rate for Royalty Income

- 12 **Sec. 101.** RCW 82.04.2907 and 2010 1st sp.s. c 23 s 107 are each 13 amended to read as follows:
- (1) Upon every person engaging within this state in the business of receiving income from royalties, the amount of tax with respect to the business is equal to the gross income from royalties multiplied by the rate ((of 0.484 percent)) provided in RCW 82.04.290(2)(a).
- 18 (2) For the purposes of this section, "gross income from 19 royalties" means compensation for the use of intangible property, 20 including charges in the nature of royalties, regardless of where the

- NEW SECTION. **Sec. 201.** (1) The commerce clause of the United States Constitution as currently interpreted by the United States supreme court prohibits states from imposing sales or use tax collection obligations on out-of-state businesses unless the business has a substantial nexus with the taxing state.
  - (2) The legislature recognizes that under the United States supreme court's decision in *Quill Corp. v. North Dakota*, 504 U.S. 298 (1992), a substantial nexus for sales and use tax collection purposes requires that the taxpayer have a physical presence in the taxing state.
- 20 (3) The legislature further recognizes that the requisite 21 physical presence can be established directly through a taxpayer's 22 own activities in the taxing state, or indirectly, through 23 independent contractors, agents, or other representatives who act on 24 behalf of the taxpayer in the taxing state.
  - (4) However, the legislature finds that because the United States supreme court has not clearly defined the circumstances under which a physical presence is sufficient to establish a substantial nexus for tax purposes, frequent conflicts have arisen throughout the country among state taxing authorities, taxpayers, tax practitioners, and courts.
- 31 (5) Therefore, the legislature intends to provide more clarity 32 for out-of-state sellers that compensate Washington residents for 33 referring customers to the out-of-state seller by providing clear 34 statutory guidelines for determining when these out-of-state sellers 35 are required to collect Washington's retail sales tax.

NEW SECTION. Sec. 202. A new section is added to chapter 82.08
RCW to be codified between RCW 82.08.050 and 82.08.054 to read as
follows:

- (1) For purposes of this chapter, a remote seller is presumed to 4 have a substantial nexus with this state and is obligated to collect 5 б retail sales tax if the remote seller enters into an agreement with a resident of this state under which the resident, for a commission or 7 other consideration, directly or indirectly refers 8 customers, whether by a link on an internet web site or otherwise, to 9 the remote seller, if the cumulative gross receipts from sales by the 10 11 remote seller to customers in this state who are referred to the 12 remote seller by all residents with this type of an agreement with the remote seller exceed ten thousand dollars during the preceding 13 calendar year. This presumption may be rebutted by proof that the 14 resident with whom the remote seller has an agreement did not engage 15 16 in any solicitation in this state on behalf of the remote seller that 17 would satisfy the nexus requirement of the United States Constitution 18 during the calendar year in question. Proof may be shown by (a) establishing, in a manner acceptable to the department, that (i) each 19 in-state person with whom the remote seller has an agreement is 20 21 prohibited from engaging in any solicitation activities in this state that refer potential customers to the remote seller, and (ii) such 22 in-state person or persons have complied with that prohibition; or 23 24 (b) any other means as may be approved by the department.
  - (2) "Remote seller" means a seller that makes retail sales in this state through one or more agreements described in subsection (1) of this section, and the seller's other physical presence in this state, if any, is not sufficient to establish a retail sales or use tax collection obligation under the commerce clause of the United States Constitution.
- 31 (3) Nothing in this section may be construed to affect in any way 32 RCW 82.04.424, 82.08.050(11), or 82.12.040(5).
  - (4) This section is subject to section 205 of this act.

  - (1) A person engaging in business is deemed to have substantial nexus with this state if the person is:
    - (a) An individual and is a resident or domiciliary of this state;
- 9 (b) A business entity and is organized or commercially domiciled 10 in this state; or
  - (c) A nonresident individual or a business entity that is organized or commercially domiciled outside this state, and in ((any)) the immediately preceding tax year the person ((has)) had:
    - (i) More than fifty thousand dollars of property in this state;
    - (ii) More than fifty thousand dollars of payroll in this state;

However, if a loan or credit card receivable is charged off in whole or in part for federal income tax purposes, the portion of the loan or credit card receivable charged off is deducted from the outstanding principal balance.
  - (ii) Property rented by the taxpayer is valued at eight times the net annual rental rate. For purposes of this subsection, "net annual rental rate" means the annual rental rate paid by the taxpayer less any annual rental rate received by the taxpayer from subrentals.
- (c) The average value of property must be determined by averaging 37 the values at the beginning and ending of the tax year; but the department may require the averaging of monthly values during the tax

1 year if reasonably required to properly reflect the average value of 2 the taxpayer's property.

- (d)(i) For purposes of this subsection (2), loans and credit card receivables are deemed owned and used in this state as follows:
- (A) Loans secured by real property, personal property, or both 5 б real and personal property  $((\tau))$  are deemed owned and used in the 7 state if the real property or personal property securing the loan is located within this state. If the property securing the loan is 8 located both within this state and one or more other states, the loan 9 is deemed owned and used in this state if more than fifty percent of 10 11 the fair market value of the real or personal property is located within this state. - 31 (B) "Credit card" means a card or device existing for the purpose 32 of obtaining money, property, labor, or services on credit.
  - (e) Notwithstanding anything else to the contrary in this subsection, property counting toward the thresholds in subsection (1)(c)(i) and (iv) of this section does not include a person's ownership of, or rights in, computer software as defined in RCW 82.04.215, including computer software used in providing a digital automated service; master copies of software; and digital goods and digital codes residing on servers located in this state.

- (3)(a) Payroll counting toward the thresholds in subsection (1)(c)(ii) and (iv) of this section is the total amount paid by the taxpayer for compensation in this state during the immediately plus nonemployee compensation preceding tax year representative third parties in this state. Nonemployee compensation б paid to representative third parties includes the gross amount paid to nonemployees who represent the taxpayer in interactions with the taxpayer's clients and includes sales commissions.
  - (b) Employee compensation is paid in this state if the compensation is properly reportable to this state for unemployment compensation tax purposes, regardless of whether the compensation was actually reported to this state.

- (c) Nonemployee compensation is paid in this state if the service performed by the representative third party occurs entirely or primarily within this state.
- (d) For purposes of this subsection, "compensation" means wages, salaries, commissions, and any other form of remuneration paid to employees or nonemployees and defined as gross income under 26 U.S.C. Sec. 61 of the federal internal revenue code of 1986, as existing on June 1, 2010.

  - (5)(a) Each December, the department must review the cumulative percentage change in the consumer price index. The department must adjust the thresholds in subsection (1)(c)(i) through (iii) of this section if the consumer price index has changed by five percent or more since the later of June 1, 2010, or the date that the thresholds were last adjusted under this subsection. For purposes of determining the cumulative percentage change in the consumer price index, the department must compare the consumer price index available as of December 1st of the current year with the consumer price index as of

the later of June 1, 2010, or the date that the thresholds were last adjusted under this subsection. The thresholds must be adjusted to reflect that cumulative percentage change in the consumer price index. The adjusted thresholds must be rounded to the nearest one thousand dollars. Any adjustment will apply to tax periods that begin after the adjustment is made.

- (b) As used in this subsection, "consumer price index" means the consumer price index for all urban consumers (CPI-U) available from the bureau of labor statistics of the United States department of labor.

    - (2) For purposes of this section:

- (a) A change in federal law conflicts with section 202 of this act if the change clearly allows states to impose greater sales and use tax collection obligations on remote sellers than provided for, or clearly prevents states from imposing sales and use tax collection obligations on remote sellers to the extent provided for, under section 202 of this act.
- (b) A change in the streamlined sales and use tax agreement conflicts with section 202 of this act if one or more provisions of section 202 of this act causes this state to be found out of compliance with the streamlined sales and use tax agreement by its governing board.
- (3) If the department makes a determination under this section that a change in federal law or the streamlined sales and use tax agreement conflicts with one or more provisions of section 202 of this act, the department:
- (a) May adopt rules in accordance with chapter 34.05 RCW that are consistent with the streamlined sales and use tax agreement and that impose sales and use tax collection obligations on remote sellers to the fullest extent allowed under state and federal law; and

Manufacturing Machinery and Equipment Exemption for Software

Manufacturers

- (1)(a) The tax levied by RCW 82.08.020 does not apply to sales to a manufacturer or processor for hire of machinery and equipment used directly in a manufacturing operation or research and development operation, to sales to a person engaged in testing for a manufacturer or processor for hire of machinery and equipment used directly in a testing operation, or to sales of or charges made for labor and services rendered in respect to installing, repairing, cleaning, altering, or improving the machinery and equipment.
- (b) Except as provided in (c) of this subsection, sellers making tax-exempt sales under this section must obtain from the purchaser an exemption certificate in a form and manner prescribed by the department by rule. The seller must retain a copy of the certificate for the seller's files.
- (c)(i) The exemption under this section is in the form of a remittance for a gas distribution business, as defined in RCW 82.16.010, claiming the exemption for machinery and equipment used for the production of compressed natural gas or liquefied natural gas for use as a transportation fuel.
- (ii) A gas distribution business claiming an exemption from state and local tax in the form of a remittance under this section must pay the tax under RCW 82.08.020 and all applicable local sales taxes. Beginning July 1, 2017, the gas distribution business may then apply to the department for remittance of state and local sales and use taxes. A gas distribution business may not apply for a remittance more frequently than once a quarter. The gas distribution business must specify the amount of exempted tax claimed and the qualifying purchases for which the exemption is claimed. The gas distribution business must retain, in adequate detail, records to enable the department to determine whether the business is entitled to an exemption under this section, including: Invoices; proof of tax paid; and documents describing the machinery and equipment.
- 34 (iii) The department must determine eligibility under this 35 section based on the information provided by the gas distribution 36 business, which is subject to audit verification by the department. 37 The department must on a quarterly basis remit exempted amounts to 38 qualifying businesses who submitted applications during the previous 39 quarter.

- 1 (iv) Beginning July 1, 2028, a gas distribution business may not 2 apply for a refund under this section or RCW 82.12.02565.
  - (2) For purposes of this section and RCW 82.12.02565:
- (a) "Machinery and equipment" means industrial fixtures, devices, 4 and support facilities, and tangible personal property that becomes 5 an ingredient or component thereof, including repair parts and 6 7 replacement parts. "Machinery and equipment" includes pollution control equipment installed and used in a manufacturing operation, 8 testing operation, or research and development operation to prevent 9 air pollution, water pollution, or contamination that might otherwise 10 11 result from the manufacturing operation, testing operation, 12 research and development operation. "Machinery and equipment" also 13 includes digital goods.
  - (b) "Machinery and equipment" does not include:
- 15 (i) Hand-powered tools;

- (ii) Property with a useful life of less than one year;
- (iii) Buildings, other than machinery and equipment that is permanently affixed to or becomes a physical part of a building; and
  - (iv) Building fixtures that are not integral to the manufacturing operation, testing operation, or research and development operation that are permanently affixed to and become a physical part of a building, such as utility systems for heating, ventilation, air conditioning, communications, plumbing, or electrical.
- (c) Machinery and equipment is "used directly" in a manufacturing operation, testing operation, or research and development operation if the machinery and equipment:
- 27 (i) Acts upon or interacts with an item of tangible personal 28 property;
- 29 (ii) Conveys, transports, handles, or temporarily stores an item 30 of tangible personal property at the manufacturing site or testing 31 site;
- 32 (iii) Controls, guides, measures, verifies, aligns, regulates, or 33 tests tangible personal property at the site or away from the site;
- (iv) Provides physical support for or access to tangible personal property;
- 36 (v) Produces power for, or lubricates machinery and equipment;
- (vi) Produces another item of tangible personal property for use in the manufacturing operation, testing operation, or research and development operation;

- 1 (vii) Places tangible personal property in the container, 2 package, or wrapping in which the tangible personal property is 3 normally sold or transported; or
- 4 (viii) Is integral to research and development as defined in RCW 82.63.010.
- 6 (d) "Manufacturer" means a person that qualifies as a 7 manufacturer under RCW 82.04.110. "Manufacturer" also includes a 8 person that:
  - (i) Prints newspapers or other materials; or

- 10 <u>(ii)</u> Is engaged in the development of prewritten computer
  11 software that is not transferred to purchasers by means of tangible
  12 storage media.
  - (e) "Manufacturing" means only those activities that come within the definition of "to manufacture" in RCW 82.04.120 and are taxed as manufacturing or processing for hire under chapter 82.04 RCW, or would be taxed as such if such activity were conducted in this state or if not for an exemption or deduction. "Manufacturing" also includes printing newspapers or other materials. An activity is not taxed as manufacturing or processing for hire under chapter 82.04 RCW if the activity is within the purview of chapter 82.16 RCW.
  - (f) "Manufacturing operation" means the manufacturing articles, substances, or commodities for sale as tangible personal property. A manufacturing operation begins at the point where the raw materials enter the manufacturing site and ends at the point where the processed material leaves the manufacturing site. With respect to the production of class A or exceptional quality biosolids by a wastewater treatment facility, the manufacturing operation begins at the point where class B biosolids undergo additional processing to achieve class A or exceptional quality standards. Notwithstanding anything to the contrary in this section, the term also includes that portion of a cogeneration project that is used to generate power for consumption within the manufacturing site of which the cogeneration project is an integral part. The term does not include the preparation of food products on the premises of a person selling food products at retail.
- 36 (g) "Cogeneration" means the simultaneous generation of 37 electrical energy and low-grade heat from the same fuel.
- (h) "Research and development operation" means engaging in research and development as defined in RCW 82.63.010 by a manufacturer or processor for hire.

- 1 (i) "Testing" means activities performed to establish or 2 determine the properties, qualities, and limitations of tangible 3 personal property.
- (j) "Testing operation" means the testing of tangible personal 4 5 property for a manufacturer or processor for hire. A testing 6 operation begins at the point where the tangible personal property enters the testing site and ends at the point where the tangible 7 personal property leaves the testing site. The term also includes the 8 testing of tangible personal property for use in that portion of a 9 cogeneration project that is used to generate power for consumption 10 within the manufacturing site of which the cogeneration project is an 11 12 integral part. The term does not include the testing of tangible personal property for use in the production of electricity by a light 13 and power business as defined in RCW 82.16.010 or the preparation of 14 food products on the premises of a person selling food products at 15 16 retail.
  - (3) This section does not apply (a) to sales of machinery and equipment used directly in the manufacturing, research and development, or testing of marijuana, useable marijuana, or marijuana-infused products, or (b) to sales of or charges made for labor and services rendered in respect to installing, repairing, cleaning, altering, or improving such machinery and equipment.
- 23 (4) The exemptions in this section do not apply to an ineligible 24 person. For purposes of this subsection, the following definitions 25 apply:
  - (a) "Affiliated group" means a group of two or more entities that are either:
    - (i) Affiliated as defined in RCW 82.32.655; or

- 33 (1) If payment of any tax due on a return to be filed by a 34 taxpayer is not received by the department of revenue by the due 35 date, there is assessed a penalty of ((five)) nine percent of the

- 1 amount of the tax; and if the tax is not received on or before the last day of the month following the due date, there is assessed a 2 total penalty of ((fifteen)) nineteen percent of the amount of the 3 tax under this subsection; and if the tax is not received on or 4 before the last day of the second month following the due date, there 5 6 is assessed a total penalty of ((twenty-five)) twenty-nine percent of 7 the amount of the tax under this subsection. No penalty so added may be less than five dollars. 8
- (2) If the department of revenue determines that any tax has been 9 substantially underpaid, there is assessed a penalty of five percent 10 11 of the amount of the tax determined by the department to be due. If payment of any tax determined by the department to be due is not 12 received by the department by the due date specified in the notice, 13 or any extension thereof, there is assessed a total penalty of 14 fifteen percent of the amount of the tax under this subsection; and 15 16 if payment of any tax determined by the department to be due is not 17 received on or before the thirtieth day following the due date specified in the notice of tax due, or any extension thereof, there 18 is assessed a total penalty of twenty-five percent of the amount of 19 the tax under this subsection. As used in this section, "substantially underpaid" means that the taxpayer has paid less than eighty percent of the 22 amount of tax determined by the department to be due for all of the 23 24 types of taxes included in, and for the entire period of time covered 25 by, the department's examination, and the amount of underpayment is 26 at least one thousand dollars.
  - (3) If a warrant is issued by the department of revenue for the collection of taxes, increases, and penalties, there is added thereto a penalty of ten percent of the amount of the tax, but not less than ten dollars.

(5) If the department finds that a taxpayer has disregarded specific written instructions as to reporting or tax liabilities, or willfully disregarded the requirement to file returns or remit payment electronically, as provided by RCW 82.32.080, the department must add a penalty of ten percent of the amount of the tax that should have been reported and/or paid electronically or additional tax found due if there is a deficiency because of the failure to follow the instructions. A taxpayer disregards specific written instructions when the department has informed the taxpayer in writing of the taxpayer's tax obligations and the taxpayer fails to act in accordance with those instructions unless, in the case of a deficiency, the department has not issued final instructions because the matter is under appeal pursuant to this chapter or departmental regulations. The department may not assess the penalty under this section upon any taxpayer who has made a good faith effort to comply with the specific written instructions provided by the department to that taxpayer. A taxpayer will be considered to have made a good faith effort to comply with specific written instructions to file returns and/or remit taxes electronically only if the taxpayer can show good cause, as defined in RCW 82.32.080, for the failure to comply with such instructions. A taxpayer will be considered to have willfully disregarded the requirement to file returns or remit payment electronically if the department has mailed or otherwise delivered the specific written instructions to the taxpayer on at least two occasions. Specific written instructions may be given as a part of a tax assessment, audit, determination, closing agreement, or other written communication, provided that such specific written instructions apply only to the taxpayer addressed or referenced on communication. Any specific written instructions department must be clearly identified as such and must inform the taxpayer that failure to follow the instructions may subject the taxpayer to the penalties imposed by this subsection. If the department determines that it is necessary to provide specific written instructions to a taxpayer that does not comply with the requirement to file returns or remit payment electronically as provided in RCW 82.32.080, the specific written instructions must provide the taxpayer with a minimum of forty-five days to come into compliance with its electronic filing and/or payment obligations

- before the department may impose the penalty authorized in this
  subsection.
- (6) If the department finds that all or any part of a deficiency 3 resulted from engaging in a disregarded transaction, as described in 4 RCW 82.32.655(3), the department must assess a penalty of thirty-five 5 6 percent of the additional tax found to be due as a result of engaging 7 a transaction disregarded by the department under 82.32.655(2). The penalty provided in this subsection may be assessed 8 9 together with any other applicable penalties provided in this section on the same tax found to be due, except for the evasion penalty 10 11 provided in subsection (7) of this section. The department may not assess the penalty under this subsection if, before the department 12 discovers the taxpayer's use of a transaction described under RCW 13 14 82.32.655(3), the taxpayer discloses its participation in the 15 transaction to the department.
- 16 (7) If the department finds that all or any part of the 17 deficiency resulted from an intent to evade the tax payable 18 hereunder, a further penalty of fifty percent of the additional tax 19 found to be due must be added.
  - (8) The penalties imposed under subsections (1) through (4) of this section can each be imposed on the same tax found to be due. This subsection does not prohibit or restrict the application of other penalties authorized by law.
  - (9) The department may not impose the evasion penalty in combination with the penalty for disregarding specific written instructions or the penalty provided in subsection (6) of this section on the same tax found to be due.
  - (10) For the purposes of this section, "return" means any document a person is required by the state of Washington to file to satisfy or establish a tax or fee obligation that is administered or collected by the department, and that has a statutorily defined due date.
